4. City Centre Overview

4.1 DfC Environmental Schemes-Gary Hammond

- **Belfast: Streets Ahead Phase 3;** The Deign Team are reviewing the original scheme designs and updating to take account of changes, such as A Bolder Vision for Belfast. Work is ongoing to address a number of issues before a new planning application can be submitted and a new business case completed.
- **Belfast: Streets Ahead Phase 5;** The Design Team continues to develop the concept designs for the project area. DfC has engaged with DfI to ensure that the design proposals are in line with DfI's revised Belfast Metropolitan Transport Plan which is currently being developed. It is intended that the construction phase will take place following the completion of Phase 3.
- **High Street** This is a DfI lead project with DfC contributing funding towards the public realm improvements. DfC is waiting to hear from DfI regarding when the project will be progressed.
- **Clifton Gateway Project** Work to re-design the carriageway from Carlisle Circus to the Clifton Street/Frederick Street junction is ongoing with this work anticipated to be completed for the end of the year. Following this DfC will consider the next steps.
- **Five Cs Public Realm Scheme** Developed design is underway with Key Stakeholder engagement planned for the coming months. It is intended that a planning application for the project area will be submitted in mid 2023.

NB: progression of all schemes are subject to completion of a business case, planning approval and budget being in place.



OPEN SPACES

- Blackstaff Square DfC is currently considering taking forward a section of the Phase 5 project around Blackstaff Square ahead of the main project. Discussions regarding this is ongoing.
- Bank Square New bollards have been ordered to close off the Square to traffic now that the cordon for the Bank Buildings have been removed. A one-way system is in place, entering via Bank Street and exiting via Berry Street. Work is continuing with the Council and local businesses to bring the Square back to life.
- Custom House Square The Square is currently being used to facilitate the refurbishment of Custom House. Completion date is estimated to be W/C 2/1/23
- Writer's Square Tumble Circus's Winter Circus will be on site form 12th December through to the first week in January. The Department are currently exploring options for animation of the area.



4.2 Key Milestones – Geraldine Duggan

4.2.1 Ulster University

- Significant uplift in footfall and activity in the city centre since start of term.
- Vibrant and high impact city dressing campaign to welcome students and staff to the new Campus and the city centre.

4.2.2 CastleCourt

- Development ongoing and on programme.
- Starbucks café bringing activity onto Royal Avenue.

4.2.3 Castle Junction

- Cordon Removal has reopened Castle Place and linkages to Royal Avenue, Castle Street & Bank Square.
- Cycle only & pavement café on junction at Castle Street.



4.2 Key Milestones – Geraldine Duggan

4.2.4 Dunbar Link/ York Street Junction

- Interim works commenced to increase central reservation for safer pedestrian crossing.
- Longer term plans in place for Fredrick Street / Dunbar Link junction
 - timings of works to be agreed.

4.2.5 Glider G3 (BRT2)

- Preferred North / South route announced.
- Proposed G3 route along the Antrim Road in the north, and along the Ormeau Road and Saintfield Road in the south.
- The Titanic Quarter Glider G2 service will also be extended to connect with Queen's University and the City Hospital.




